**INSTITUT AGAMA ISLAM NEGERI (IAIN) Syekh Nurjati Cirebon, Indonesia** whose address is at **Jalan Perjuangan Bypass Sunyaragi, Cirebon, Indonesia** of the first part and shall include its lawful representatives and permitted assigns; **And Marmara University Faculty of Theology Istanbul Turkey** of the second part whose address is at **Bağlarbaşı Kampusu 34662, Üsküdar-Istanbul Turkey** and shall include its lawful representatives and permitted assigns;

**HAVE REACHED AN UNDERSTANDING** as follows

**OBJECTIVE**

The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations and national policies from time to time in force in each Party's country, will Endeavour to strengthen, promote and develop Islamic Sciences and researches, co-operation between the Parties on the basis of equality and mutual benefit.

**AREAS OF CO-OPERATION**

Each Party will, subject to the laws, rules, regulations and national policies from time to time in force, governing the subject matter in their respective countries, Endeavour to take necessary steps to encourage and promote co-operation in the following areas:

1. Exchange of faculty members and/or researchers with the objective of offering courses and realizing research projects in areas mutually agreed upon by both universities;
2. Exchange of undergraduate and graduate students with the objective of enrolling students in courses appropriate to their year and area of study;
3. Exchange of books, scientific publications, study programs, academic projects, course information, seminars, conferences and any other data and information of common interest and;
4. Develop joint research projects and joint publications;
5. All joint activities will be realized through the mutual agreement and clearly established conditions and mutual obligations by the Parties.

#### **FINANCIAL ARRANGEMENTS**

1. This Memorandum of Understanding will not give rise to any financial obligation by one Party to the other.
2. Each Party will bear its own cost and expenses in relation to this Memorandum of Understanding.



IN WITNESS WHEREOF the Parties have hereunto caused this Memorandum of Understanding (MoU) to be duly executed as at the date first above mentioned.


